EFFORTLESS CODE 60 MANAGEMENT

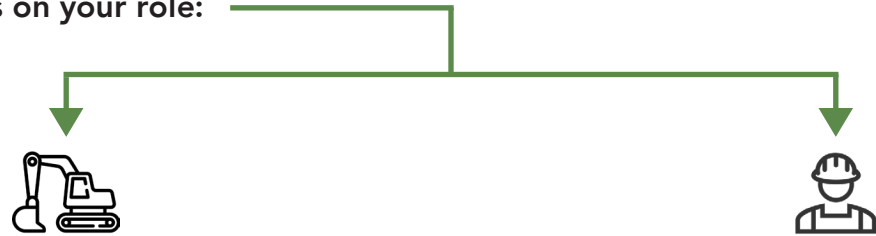
Say goodbye to the hassle of managing Code 60 requests via emails.

There is even a function excavators can activate to automatically decline Code 60s submitted after 6:00 PM the day before the 7:00 AM Locate Request Due by Date.

REGISTRATION PROCESS

TO GET STARTED WITH ERMA, YOU'LL NEED TO REGISTER FOR AN ACCOUNT.

The process depends on your role:



Excavators Who Create Locate Requests

1. You will need to provide the **same mobile phone number or email address** that you have used on your Locate Requests with Virginia 811.
2. Ensure you have **access to both the valid mobile phone number and email address** entered in order to complete the verification steps.
3. **Download the ERMA app** from your app store.
4. Open the app and select the option to **"Register New Account."**
5. Check both your email inbox and your mobile phone for **one-time passcodes**. Enter these passcodes in the app to complete the verification process.
6. Once verified, you'll have **full access to ERMA's features**.

Field Contacts on Locate Requests

1. You will need to **enter the phone number that is listed as the Field Contact phone number** on relevant Locate Requests when registering for an account.
2. **Download the ERMA app** from your app store.
3. Open the app and select the option to **"Register New Account."**
4. **Provide your preferred email address** for registration.
5. **Look for one-time passcodes** in your email inbox and on your mobile phone. **Enter these codes** in the app to verify your account.
6. Once verified, you'll have **full access to ERMA's features**.

NOTIFICATION SETTINGS

Customizing your notification preferences in ERMA is easy. Here's how you can tailor your notifications to suit your needs:

1. Accessing Notification Settings:

- To configure your notification preferences, start by navigating to your Profile. You can do this by selecting the Profile option at the bottom of the screen.

2. Opting In or Out:

- Within your Profile, you'll find a section labeled "Settings." Here, you can choose to opt in or out of receiving push notifications from ERMA. Toggle this option according to your preference.

3. Batch Notifications at 5:00 PM EST:

- Want to receive notifications all at once? ERMA offers the option to receive batch notifications.

AUTOMATIC CODE 60 REJECTION

ERMA offers a convenient feature that can help you manage Code 60 responses more efficiently. You have the option to automatically reject Code 60 responses submitted after 6:00 PM EST on the business day prior to the Locate Request's Due by Date.

To take advantage of this time-saving feature, follow these steps:

1. Navigate to your Profile within the ERMA app
2. Look for **"Automatic Rejection"** in the Settings area.
3. Check this option to activate automatic rejection for Code 60 responses submitted after 6pm the day before a Locate Request's Due by Date.

By enabling this feature, ERMA will automatically decline Code 60 responses received after the specified time, helping you maintain project timelines and avoid unnecessary delays.

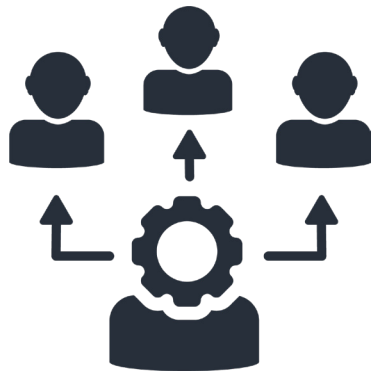

ADMINISTRATOR FUNCTIONALITY FOR EXCAVATION COMPANIES

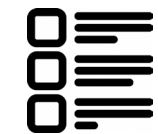
BASIC FUNCTIONALITY

Viewing Locate Requests

Easily access and review your Locate Requests within the app. Each Locate Request can be expanded into a detailed view by simply tapping on the Locate Request in question. This detailed view provides comprehensive information about each request including relevant dates and times, address information, and responses.



Effortless Code 60 Response Handling

When managing Code 60 responses, ERMA offers flexibility. You can choose to:

- Accept or reject all Code 60 responses on an individual ticket, making batch actions convenient.
- Individually address each Code 60 response for precise control.

Additionally, there's a filter at the top of the dashboard page that enables you to quickly filter down to Locate Requests with Code 60 Action Required.
